- During the year it was my pleasure to join other members of the club to attend and support numerous events held by our sister clubs here in Western Australia.

- Club member, Donella Caspersz, continued the Area 3 Coordination of the JMK Award and we were all delighted to learn that the Area 3 Winner, Gabrielle Walker, was also selected as the District 23 JMK Awardee. A number of club members attended a special event at the Zonta Club of Swan Hills for the presentation.
- In June the Service and Advocacy Team held another very successful quiz night supporting, Zonta House, Positive Pathways/Starting Over Support (SOS) and Birthing Kits.





- The PR & Archives team held a very successful Spring Luncheon & Fashion Launch of Leah Helean's new range of hand painted silk outfits and matching millinery. This was held at the beautiful Royal Perth Yacht Club.
- After attending a number of events for 100 Women, the Zonta Club of Perth voted to join the organization to support the projects which align very closely with the work of Zonta.
- Wendy Atherden and Donella Caspersz have been pursuing an issue around Domestic Violence and temporary visa holders and our club is working closely with a group of women in the Mirrabooka area, in partnership with Ishar the Multicultural Women's Group.
- Carole Theobald and I have been working on the Collaborate WA Feasibility Study along with representatives of other women's organizations in WA. This group also oversees the WA Women's Hall of Fame annual event, so our club is well represented in the planning and execution of the very public acknowledgement of women's contribution to Western Australia.
- Our Membership and Program team has done a wonderful job in encouraging four new members, with an extra two new members to be inducted at our AGM. The change to having speakers at all our meetings has ensured that our meetings are always interesting.
- Vera Riley has taken charge of the Golden Z Club and they are off to a flying start for 2016 with continued involvement and increasing numbers.
- I was touched by the commitment of members to ensure that our friends on the Gibb River were adequately clothed for last winter. Unfortunately this coincided with the tragic death of Yvonne Burgu – dearly loved by so many in our club. I thank Carole and David Theobald and Sciona Browne for making the journey to the Kimberley for Yvonne's funeral. As a result the club will be launching a new scholarship in 2016/17 in Yvonne's name.
- The club has enthusiastically engaged with the running of the 2016 Area 3 Workshop

2. Awards and Holidays

The Young Woman in Public Affairs Award

This is an International Award presented at Club, District and Zonta International levels. Information was circulated to 38 schools in our region in February, with emails following up with reminders. We were disappointed to receive only three applications this year, but all were outstanding young women who were contributing at their schools and to their individual communities.

Selections were made by Wendy MacGibbon, Donella Caspersz and Cath Spitteler a former Perth Zontian.

The winner was Claire Burwood from Kelmscott Senior High School. A presentation of a cheque and certificate will be made at the 2016 AGM and dinner.

The University Education Award

This is awarded each year to a woman over 25 years who has satisfactorily completed one year of a degree course and who demonstrates financial need. All universities have the information on this award on their websites. The closing date is early May 2016. Kate Ellson manages this award.

In 2015 Club members agreed to present two awards as the selection committee had difficulty in deciding a clear winner. Rosalie Jane Lorenzi and Lara Allen were both worthy recipients and received their cheques for \$2,000 each at the July meeting when they made presentations to the club.

The Jane M Klausman Woman in Business Scholarship

This International Award is for women pursuing an Undergraduate or Masters Degree in Business Management. Donella Caspersz manages this award for Area 3. During the year we were pleased that the Area 3 award went to Gabrielle Walker, a student at Murdoch University. She was presented with her Area 3 Award at the Swan Hills Club in November 2015.

Gabrielle, an outstanding candidate with a strong academic record, displayed evidence of leadership in her research and voluntary work, and we were delighted when she went on to win the District 23 scholarship. Her professional goals are to set up a business empowering women to live with integrity while reaching their full potential.

Nominations have now been called for the 2016 award. These will close on May 16th.

The Yvonne Burgu Scholarship

This new scholarship was proposed by Karen Groves and adopted at the March club meeting. This scholarship recognises the special connection between the Club and the indigenous communities along the Gibb River Road in the Kimberley.

It honours the late Yvonne Burgu a senior law-woman who passed away after a vehicle accident in 2015.

Yvonne was a key person in the Gibb River community who empathised with the concept of women helping women. She saw education of the young people as a key to intercepting the cycle of dysfunction in her communities.

The aim of the scholarship is to grant an indigenous woman, preferably from the Kimberley or another remote area of WA, who is in her second year of tertiary education in Perth or in a regional centre, an amount of \$1,000 for one year only to support continuing study.

The scholarship honours a key woman in the Gibb River community, meets the needs of Zonta to provide educational opportunities for women who need support, and continues the relationship with women from the Kimberley. This team will be administering the scholarship process.

Zonta Holidays

The Zonta Holiday Trust was established in the 1980s when the Club had a major fundraising drive and invested funds to be able to provide holidays for disadvantaged families in need. The Club has a good relationship with the Rotary Club of Albany City which has two properties with disabled access available at Emu Point.

In 2015 we provided holidays to two families which were greatly appreciated. Unfortunately a third family was unable to travel to Albany after the holiday start date because of a car breakdown and some relationship issues. The Rotary Club generously refunded the week's rent. The Holidays have been managed by Jill Anderson after a handover from Wendy MacGibbon early in the year.

Area 3 Workshop

Our club hosted the Area 3 Workshop this year. The team has been well represented by Jill Anderson and Donella Caspersz in the organising of the event.

The PR and Archive Team had another busy year supporting the club, District 23 and the WA International Women's Day Collaboration.

Club activities

Club fundraising activities included the team organising a successful Fashion Show and Luncheon event with local fashion designer, Leah Helean (Judy Gorton's talented daughter) at the Royal Perth Yacht Club. In particular, Judy Gorton and Chrissie Hodges did a great job and the event attracted over 140 attendees and raised over \$8,000.

On the service front Sciona Browne organized a clothing drive for the Gibb River community and it was with sadness a few weeks later that we heard of the death of our friend Yvonne Burgu in a car accident.

Yvonne was the leader of the Gibb River Community and in August, Carole Theobald and Sciona Browne attended the funeral of this inspirational woman who was buried in the small cemetery at Gibb River. Her grave is near that of her (and our) friend, Kathy Charlesworth who had introduced our club to this remote Ngarinyin community in 2004.

Administratively, the team has worked behind the scenes to produce the Members List,

Annual Report, brochures, certificates, new member packs, website and newsletters. Vicky Nazer has been building a relationship with the local newspapers and the Little Aussie Directories have given us free advertising.

Deanna Byers shared the role of Inzert editor with Carole Theobald and captured the history of the club in e-friendly newsletters that included a special edition to celebrate the life of Yvonne Burgu.

Our thanks go to FoodStars P/L who had freely hosted our website for over ten years, but could no longer do so when they changed their server mid-year. Flexihostings now hosts our website for free as part of their community service program and we appreciate their support.

At the District 23 Conference all clubs were given new club banners sporting the new Zonta logo and these looked very impressive when displayed at the Area 3 Workshop that our club hosted in April. The team produced the Acknowledgement of Country PowerPoint presentation for this event that featured the Wanjoo song, sung by Gina Williams in the local Noongar language.

District activities

Lennie McCall and 'Tricia Summerfield joined our team for a few meetings so that we could help out with some district history and archive activities. These included photographing all of the club photographic displays from the last five district conferences and putting the images on DVD for the D23 centenary

Carole Theobald has also been providing input to the new District web site currently being designed by a company in Adelaide.

IWD WA Collaboration activities

The International Women's Day Collaboration has had an active year and Carole Theobald, Judy Gorton and Sandra Burns have all provided contribution to a feasibility study on setting up an entity for gender equality in WA, liaised with a consultant investigating an enduring memorial for the WA Women's Hall of Fame and participated in the selection process for the 2016 WA Women's Hall of Fame inductees. At the Hall of Fame induction ceremony, Carole was privileged to host the Governor, Kerrie Sanderson, for the evening.

The Collaboration joined with Heritage WA to produce an event that celebrated the women parliamentarians in the Hall of Fame. This event was held in the Upper Chamber of the WA Parliament and involved members of the Collaboration dressing up in period costume as early WA suffragists with Carole Theobald playing the role of the ghost of Edith Cowan. Later, Carole's photograph appeared in every local community newspaper in the state as part of the advertising for nominations for the WA Women's Hall of Fame.

Team members

It was with regret that we learned of the resignation of Deanna Byers due to ill health mid-year and we thank her for her marvelous contribution to the club. Helen Margaria had

been on a leave of absence, but also recently resigned due to increasing work commitments and we appreciate her 24 years of valued service to Zonta. We will miss them both.

5. Service and Advocacy

This year the Service and Advocacy Team have continued to develop, lead and support a number of service and advocacy projects. During the first six months the team was led by Ronette Druskovich, who then handed the baton onto

Linda Higgie over the Christmas Break, when Ronette undertook an exciting employment opportunity overseas. The commitment and support of committee members is greatly appreciated and has enabled projects to continue without delay.

Multi-cultural Awareness

We are pleased to be working closely with Ishar Multicultural Women's Health Centre to support the work they are doing to support women from culturally and linguistically diverse backgrounds (CALD) who experience domestic violence.

Club member Wendy Atherden has provided outstanding leadership and initiative providing advocacy and working with the women to identify how club members can best support them. Our club has supported Ishar to apply for a grant to fund their program into the future and plans to host some picnic events during the year so that members may get to meet some of these courageous women.

The club is also currently advocating to include reference to gender violence in the

visa conditions for people working in Australia on 457 visas.

Zonta House Refuge, Positive Pathways and Starting Over Support - \$2,000 donated

The club continues its strong commitment to supporting local women experiencing homelessness as a result of family and domestic violence. We have provided service, advocacy and fundraising activities to benefit the Zonta House Women's Refuge, the continuation of the Positive Pathways Program and the growth of the Starting Over Support (SOS) initiative. These services have demonstrated effective programs to assist women to recover from trauma and gain sustainable positive changes in their lives.

Committee member Mary Gurgone has been an active Board member of the Zonta House Refuge for a number of years, some as Chair, and Linda Higgie recently joined the Board.

Club member Deb Mason continues to lead the work of the Starting Over Support Service to provide household furniture and goods to women and families moving into their own accommodation. This success of this service has grown so much that it soon will operate as a stand-alone service provide

It was a great way to meet other supporters of Zonta House and raised much needed funds to support women in our community experiencing homelessness through family and domestic violence. Over \$4,000 was raised.

City to Surf for Zonta House Refuge

Some members from the Club took part in the City to Surf in August, walking to raise funds for Zonta House Women's Refuge. Participating members joined other supporters of Zonta House and wore T-shirt with logos and the words "working together to stop family and domestic violence" on the back. This provided a great opportunity to do some advocacy, fundraising and promote the great work of Zonta within the community.

White Ribbon Day

On Friday 27 November a number of members joined representatives from the Zonta House Refuge at a stall promoting the work Zonta does to support women experiencing homelessness through family and domestic violence. The event was attended by a large crowd that heard inspirational speakers talk of their experiences, motivating change and action. The crowd peacefully participated in the Silent March from Supreme Court Gardens through central Perth at midday. This was very moving and a powerful demonstration of the power of quiet commitment and determination.

100 Women

Our club became the first service organisation in Perth to join the local philanthropic group 100 Women. 100 Women raised \$99,950 in

2015. These funds have been distributed via three grants to projects that aim to support women and girls.

The club's membership of 100 Women has enabled club members to attend 100 women events and meet with other like-minded people and learn what others are doing to enhance the lives of women.

Birthing Kits

The Birthing Kit project was adopted by District 23 in 2003 and the Zonta Club of Perth held its first assembly workshop in 2004. The Golden Z Club has been involved with the Birthing Kit project since its charter in 2013.

In 2015 the Zonta Club of Perth once again supported the Birthing Kits Foundation Australia through fundraising and hosting a Birthing Kit Assembly Day. A number of members helped out on the Birthing Kit Foundation stand at the Pregnancy, Babies and Children Expo at Claremont Showgrounds from 31 July to 2 August. It was an opportunity to work alongside members from other Zonta Clubs in WA and promote the great work of the Foundation, by educating the public and at the same time collecting donations.

On Sunday 20th September the Zonta Club of Perth and the Golden Z Club held a Birthing Kit Assembly Day at St Catherine's College in Nedlands. The day was a great success and really showcased team work on many levels and a great sense of community. The outcome was 1,000 birthing kits assembled and sent to the Birthing Kit Foundation warehouse.

On the day we had a total of 55 volunteers, 9 members of Zonta Club of Perth plus 6 family and friends of the Zonta members, 3 Curtin students who are training to be midwives, one bringing her primary school aged daughter, one person volunteering via the Birthing Kit Foundation and 35 volunteers from St Catherine's College, a substantial number being Golden Z Club members.

By funding and assembling 1,000 birthing kits, the Zonta Club of Perth and Golden Z Club have again supported the Birthing Kit Foundation in their mission of a world in which all women have access to clean and safe birthing practices. There is a commitment from both the Zonta Club of Perth and Golden Z Club in 2016 to fund and assemble another 1,000 birthing kits.

Golden Z Club of St Catherine's College, UWA

The Golden Z Club of St Catherine's College – University of Western Australia has gone from strength to strength in this, its third year. We are very proud to support this club, and note that it is the only university based Golden Z Club in Australia.

Lauren Rosher was the President of the Golden Z Club in 2014-15. In 2015 the Golden Z Club members contributed \$500 towards funding of the birthing kits and were the hosts of the Birthing Kit Assembly Day. Their efforts included recruiting 35 fellow students to help on the day. In 2016 the club has also committed to raising another \$500. The Golden Z club finished the year with \$260 of funds still banked.

The club has also formed a new executive and sub-committees namely an Activities Committee to assist with planning and organising educational and fund raising events. Zonta Club of Perth members delight in meeting with members of the Golden Z Club, who regularly have attended club dinners. It has been interesting and inspiring to hear of their academic and personal plans and passions.

7. Treasurer's Report

Our club has had another very successful year thanks to the passion, hard work and contribution of all club members.

The administration account more than

sufficiently met the budget requirements. In addition to the \$35.00 contribution from membership dues, most of the money for administration purposes comes from dinner meetings. This year dinner monies netted a surplus of \$1390.00.

This year the Club set itself the challenge of raising sufficient funds to cover service and advocacy projects and various awards.

In total, nearly \$13,400.00 was raised through the fundraising account. These funds came primarily from a quiz night and fashion parade and met the target of \$12,655.00; small amounts were also raised from individual donations, a dinner raffle and interest on investments.

The quiz night was enthusiastically supported by Zonta House and the Fashion Parade was a runaway success.

Most of the money was allocated to Service & Advocacy (\$8235.00) with donations to Zonta House Refuge, Positive Pathways and the Birthing Kits Foundation as well as various awards.

As with last year, members agreed that a second education award be awarded and so two worthy recipients benefitted from our Club's generosity. In total, \$4750.00 was awarded through the Education Awards, YWPA and JMK scholarship.

In addition, the club took up corporate membership of 100 Women.

Due to the success of the fundraising events, a generous amount of \$4245.00 was donated to the Zonta Foundation, continuing the practice of allocating a third of fundraising net income to this fund. In addition, \$100 was donated to ZIF in lieu of giving a gift to guest speakers. All the members of the club gave an individual donation (\$10 per member) to ZIF which totalled \$300.

This is my last term as Treasurer and after three years it is time to pass the baton. I have learned a great deal about Zonta – and Zonta finances – and in particular wish to thank Presidents 'Tricia Summerfield and Sandra Burns for their support and knowledge which was invaluable.
